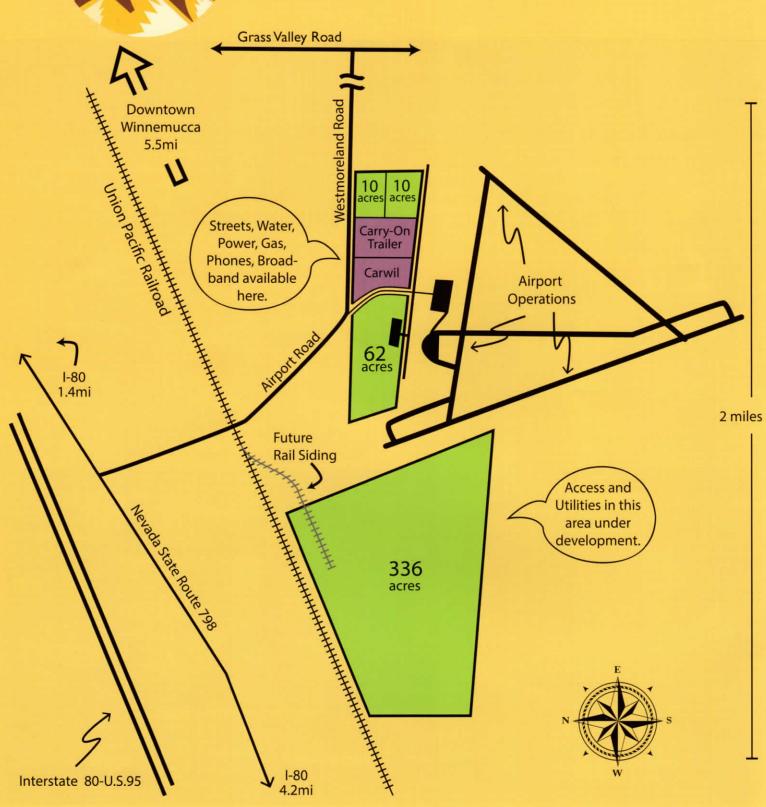
## Owned by the City of Winnemucca and Humboldt County, Nevada

- Located 2.5 miles from Interstate 80 and 6.5 miles from downtown Winnemucca.

### Industrial Park



#### Phase I

Approximately 132 acres developed.

• Currently home to one welding design & fabrication facility on a 20 acre parcel, and a utility trailer manufacturer on a 30 acre parcel.

82 acres available for occupancy and ready for construction.

 Property available at little or no cost to companies building facilities that meet the requirements of the Airport Jobs Creation Incentive Policy, (see next page.)

· Three phase power, natural gas, municipal water, broadband all available on site.

• Property available in 62, 32, 30, 10, or 5 acre parcels or re-parceled to meet needs.

#### Phase II

Approximately 336 acres currently undergoing planning and development.

Adjacent to Union Pacific Railroad with access for rail siding.

 Available at little or no cost to companies building facilities that meet the requirements of the Airport Jobs Creation Incentive Policy, (see next page.)

Available in 30, 10, or 5 acre parcels or re-parceled to meet needs.

Adjacent to airport with plans for taxiways and ramps to allow aircraft direct access.

#### Airport Proper

 Property available for lease within the airport operations boundary for aviation related businesses.



# Winnemucca Airport Industrial Park Local Incentives

The City of Winnemucca and County of Humboldt have established diversification of the local economy as one of their top priorities and have created several innovative programs to accomplish this goal.

#### Airport Jobs Creation Incentive Policy

Land in the Winnemucca Airport Industrial Park is available at greatly reduced prices, in exchange for the creation of new primary jobs.

Size of the incentive is pegged to two factors, the number of jobs and the wages paid.
 A new or expanding business that creates 100 jobs that pay 80% or above the county average wage can receive the land at no cost. Seventy five jobs that meet the wage requirement would recieve a 75% price reduction.

#### Real Estate Commission Policy

Realtors who bring high value clients to the Winnemucca Airport Industrial Park are offered up to a maximum of \$150,000 based on the value of the land, the building capital investment, and the number of jobs created.

- Commission of 10% paid on the land sale price.
- AND the Higher of:
  - 1. Commission of \$1.00 per square foot paid on the enclosed space of the industrial/commercial building(s) constructed.
  - 2. \$1000 per job for 10 to 25 jobs created, \$750 per job for

26 to 100 new jobs, and all jobs over 100 at \$500 per job.

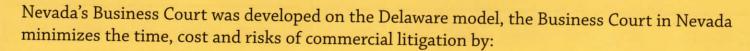

for the Winnemucca and Battle
Mountain Bureau of Land

Forest Service Ranger Districts.
